## INSURANCE DISCLOSURE



The Association's property/casualty insurance renewed April 8, 2013. Included with this newsletter is the new insurance disclosure information for the Association's current insurance policies. We encourage all homeowners to show this information to your personal insurance agents so you can purchase the appropriate personal insurance for your unit and personal possessions.

The Association's insurance does not cover everything that could be damaged, so it is extremely important that you obtain your own coverage.

The Board is looking into the parking sticker program again. We have come up with a few questions and will be trying to get answers before we bring it to the members for their evaluation.

#### **BOARD OF DIRECTORS ELECTION**

If you have read the CC&R's, you know that each year Verona homeowners elect members to serve on the Board



of Directors. The Board has the responsibility to make decisions which affect all of us. The financial decisions the Board makes determine the soundness of our funds. This authority impacts not just how financially sound Verona is today, but also how it will be years hence.

When you bought your home in Verona, it was likely a major financial decision. Protecting that investment should be important. Attending board meetings and volunteering to serve on the Board will give you insights into how the Association is faring. All homeowners in good standing are eligible to serve on the Board. We encourage you to run for a seat on the

Board. Your ideas may be just what Verona needs. In July, you will receive information about how to run for the Board. Please consider it.

## **SPRING PROJECTS**

Spring is here and many homeowners are planning their 2013 home improvement projects. Please be reminded that the Association's CC&R's require all homeowner's to submit an architectural approval application – and get written approval for that project – BEFORE making any change to their property. This includes interior projects, such as kitchen remodels.

You must also obtain written approval before having a satellite dish installed at your home. (You also need to have the dish removed when you sell your home.)

Please contact the management company if you have any questions regarding this project, or if you need a form. The forms are also readily available on the Association's website.
