### **FENCE REPLACEMENT:**

In the July Newsletter we informed you that we have selected All American Fence to replace two sections of fence and repair two other areas. We sent letters requesting additional information to owners who share the common fence that is being replaced or repaired and are still waiting for a response from some units. As of now the Board plans to start this project on September 12<sup>th</sup> or September 19<sup>th</sup>.

## **NEW LANDSCAPE COMPANY:**


